**1. Question:** You are asking for a Minimum 17" LT Series Snow Tire. Do you require a Winter Tire Package including rims, winter tires and tire pressure monitors or will an LT 275 70N R 18E be acceptable?

**Answer:** An LT275 70 R18 Tire on OEM wheels is acceptable provided they are winter snow tires as an approved equivalent. An extra tire and wheel package has not been requested.

**2. Question:** You are asking for Line X or approved equivalent. Will a factory spray in box liner be considered equivalent?

**Answer:** A factory spray in box liner is acceptable as an approved equivalent.

**3. Question:** Is the 2014 truck you show going to be a trade in? If so, would it be possible to get some pictures of the interior seats and floor?

5. **Question:** Concerning added equipment, are there equivalent brands as far as the plow, sander etc. that would be acceptable?

**Answer:** The Town has requested specific winter equipment for fleet uniformity, total interchangeability from unit to unit, and spare parts inventory purposes. The Town is open to reviewing alternate options for approved equivalents, however specifications for review are required.

6. **Question:** Can you please clarify the section of the bid marked INSURANCE from (a and (b to i and ii. We have never been asked to provide this to a customer, so we wanted to make sure of what you're asking.

**Answer:** Please see above Clarification for the requested insurance to be provided by the successful Vendor. As per the tender documents the Town is requesting a Certificate of Insurance (COI) showing the listed **Commercial General Liability Insurance** and **Automobile Liability** insurance with the listed amounts and showing the Town as the certificate holder, as well a WSIB Certificate.
