Accessibility Compliance Report

You can use one form to file an accessibility compliance report for up to 20 organizations. To do so, you need each organization's:

- legal name
- business number (BN9) or AODA identifier
- number of employees in Ontario
- address

Each organization must have the same:

- organization category
- number of employees range (e.g. 20-49, 50+)
- certifier
- answers to all of the accessibility compliance questions

If not, you will need to complete a separate form for each organization.

- volunteers
- independent contractors
- organizations with zero (0) employees are not required to submit an Accessibility Compliance Report and should submit an Organization Profile Update instead.

The Town launched a new website in early 2024. The Town states that its website "meets WCAG 2.0 Level AA standards" where possible, and continues to improve accessibility features and content. Information is provided to the public in a number of ways - including website, print, in house services, and public facilities. Members of the public can contact staff and submit inquiries / complaints / requests directly in person, or by phone, online, or through email. Town also launched a new accessible complaint forum (AccessE11), and adopted a Customer Service Policy (May 14, 2024) and Routine Disclosure Policy (April 8, 2025). The Town continues to work towards ensuring all document publicly provided are in accessible format.

Newly renovated Town Hall includes two new accessible washrooms and an accessible front counter service space. New buildings such as the MyFM Centre (recreation centre) designs have met accessible building code requirements. These features include automatic door openings, elevator access, and accessible washrooms. Ma-te-Way Park was recently updated to include an accessible outdoor play structure. Pre-existing parks and trail throughout town are scheduled for review and included in the 2025-2030 accessibility plan.

The Town has established and implemented policies that meet the AODA Customer Service Standards. We ensure that individuals with disabilities can fully access our goods and services by supporting the use of assistive devices and permitting the presence of support persons and service animals. In addition, when documentation is requested, we provide it in an accessible format that takes the person's disability into account. These measures demonstrate the Town's ongoing compliance with AODA requirements and our commitment to equitable and accessible service delivery. The Town recently established an Accessible Customer Service Plan on May 14, 2024 to provide general guidelines as to the level of customer service expected from the Town of Renfrew staff to supply the most efficient and effective service delivery. Municipal employees have been trained, equipped, and supported in meeting those customer service expectations. Ongoing training is provided and further efforts will be made to identify and train related staff in up-to-date policies and related regulations.
