BEVERAGE VENDOR APPLICATION FORM

PROCEDURES AND GUIDELINES:

By signing this form, you agree to complete and submit your application package by September 18, 2026, to book and hold your space. In the event that you do not attend once submitting this package, you will be invoiced \$200.

Your signature also confirms that you acknowledge & agree to the following:

1. Beverage Vendors are responsible for verifying that all patrons are at least 19 years of age before serving any alcoholic beverages.
2. Beverage Vendors may determine how many tickets are required per pour line and the number of ounces served per drink. However, portion sizes must remain consistent for each type of beverage served.
3. Beverage Vendors must supply their own battery-operated or solar-powered lighting for their tents, trucks, or designated spaces. Please note that electrical power is not available on-site. If additional power is needed, vendors are encouraged to bring a quiet generator or inverter.
4. Beverage Vendors are responsible for keeping their alcohol cold using ice or other methods that do not rely on power from the Town of Renfrew. Additional ice will be available for purchase on-site, while supplies last.
5. There will be 4oz and 10oz pour lines on the 16 oz Craft Beer Festival Glass being sold at the festival. Beverage Vendors must provide disposable cups for patrons who do not have a 16oz Craft Beer Festival Glass.
6. A fee of 30% is calculated based on the number of drink tickets in each Beverage Vendor's envelope at the end of the event. All tickets will be officially counted by Town of Renfrew staff on Monday, October 5. Vendors are welcome to count their tickets on the night of the event; however, please note that counts will not be verified until Monday. A direct deposit reflecting the vendor's share of 70% of sales will be mailed on Friday, October 9. An EFT must be completed and submitted by Friday, September 25, 2026 to receive your direct deposit.
7. That all Vendors must submit a completed application package to the Town of Renfrew, and all other required documents, permits or licenses that are requested.
8. That by signing this document, you are ensuring that as an Alcohol Vendor, you have all required licenses and permits that enable you to legally sell your products from your commercial location, and that your business meets all the AGCO's criteria enabling you to sell your products under the SOP obtained by the Town of Renfrew for this Festival.
