Mar. 25	Last day for candidate or registered third party to apply to Superior Court of Justice to extend the time to file the financial statement
Mar. 30 (2 p.m.)	Last day for candidates and registered third parties to file a financial statement for the reporting period ending December 31, 2026
Apr. 29 (2 p.m.)	Last day for candidates and registered third parties to file a late financial statement and pay \$500 late filing fee
Jun. 28	Last day to request a compliance audit on a financial statement for the reporting period ending December 31, 2026
Jun. 30	End of the supplementary campaign period
Jul. 28	Last day to request a compliance audit on a late financial statement for the time reporting period ending December 31, 2026, submitted by April 29, 2027
Aug. 25	Last day for Clerk to provide notice of supplementary financial filing requirements and penalties to candidates and registered third parties
Sep. 23	Last day for candidate or registered third party to apply to Superior Court of Justice to extend the time to file the supplementary financial statement
Sep. 24 (2 p.m.)	Last day for candidates and registered third parties to file a supplementary financial statement for the reporting period ending June 30, 2027
