**Items Not Captured on YouTube:** The meeting was called to order at 6:01 pm and Roll Call was completed. Two declarations of interest were noted: Councillor Dick – Heritage Permit for the Post Office and Councillor McDonald – Motion put forward by Reeve Emon.

**Announcements and Community Events:** For Community Living Month, a community flag will be flown at the Town Hall Office. Renfrew County Community Living is celebrating its 60<sup>th</sup> anniversary this year. A flag raising ceremony will take place at 10:00 am on Wednesday, May 1<sup>st</sup>.

Wednesday, April 24<sup>th</sup> is Administrative Professionals Day. Council acknowledged the collective contributions that staff have made towards the Town's day-to-day operations.

Tim Hortons will be hosting its annual Smile Cookie program from April 29-May 5. Money raised locally will be donated to the Renfrew and Area Seniors Home Support and the Renfrew Golden Age Centre.

**Stevenson Crescent:** Council awarded engineering and contract administration services to Parsons Corporation for the Stevenson Crescent Asphalt Rehabilitation project.

**Bonnechere River Park/Trail:** Council approved the Terms of Reference for the Bonnechere River Park/Trail Working Group. An expression of interest will be circulated for public appointments.

**2023 Development Charges:** Council approved the 2023 Development Charges report as prepared by the Treasurer. \$130,727.25 was collected in 2023.

Ma-te-Way Third Party Review – Completion of Mandate: Council approved the WSCS Consulting Inc. updated proposal and expanded scope of the Ma-te-Way Third Party Review to include fraud investigation.

Ma-te-Way Third Party Review – Response to Findings: Council adopted the Management Response to Findings of the Ma-te-Way Expansion Third Party Review as an action plan. All 49 recommendations were agreed to.

**Economic Development Advisory Committee:** Council approved the business member appointments for the Economic Development Advisory Committee.

**Proclamations:** Two Proclamations were noted during the meeting:

- 1) Renfrew Town Council supports the We Stand with Survivors Campaign and proclaim May as Sexual Assault Awareness Month. A banner will be raised at the Visitor Information Center for the month of May.
- 2) Renfrew Town Council proclaim May 16<sup>th</sup>, 2024 as Moose Hide Campaign Day. This Campaign is an Indigenous-led grassroots movement of men, boys and all Canadians standing up to end violence against women, children and all those along the gender Continuum.

**Notices of Motion:** Council defeated the motion to remove Councillor John McDonald from all committees, groups and boards in which he has been tasked to be a representative of the Town. Reeve Emon gave notice of a second motion involving another Councillor for consideration at the next meeting. Councillor Legris gave notice for two motions, involving promissory notes and accessible parking.
