<u>Landfill Excavator:</u> Council approved the purchase a Toromont CAT excavator for use at the Renfrew Landfill The purchase price of \$378,500 is \$34,838 less than budgeted.

<u>Reconstruction</u> (Highway 60 – Mask Road to Wrangler Road): Council approved a purchase and sale agreement and MOU with three local property owners to assume lands for the necessary road widenings at the O'Brien Road/Wrangler Road/Innovation Drive intersection.

<u>Sale of 210 Ready Ave. Lot</u> – Council agreed to enter into a *Purchase and Sale Agreement* with Lero Properties for 210 Ready Ave. The property is intended for a future 24-unit housing development with proceeds from the sale expected to be directed to enhancements outlined in the Parks, Recreation, and Waterfront Master Plan.

Extension of Existing Crop Agreement – Council re-entered into a 5-year crop agreement with Schouten Farms for agricultural use of lands between Gillan, Whitton, and O'Brien Roads.

Monthly Beverage "Pop-Up" Vehicle: In support of local downtown business, In A Bind, Council approved the operation of a refreshment vehicle in front of 158 Raglan Street South on July 14, August 11, and September 8, 2024.

Corporate Video Surveillance Policy: Council adopted a *Corporate Video Surveillance Policy* to regulate the use of video surveillance systems in Town-owned facilities, ensuring compliance with relevant legislation while enhancing safety and security.

<u>Canada East Wrestling Finals</u>: Council endorsed the Renfrew Amateur Wrestling Club in hosting the wrestling finals at the myFM Centre on May 10th and 11th in 2025.
