

Town of Renfrew Council Summary

Council adopted the following Resolutions:

- That Renfrew Town Council direct staff to proceed with a medical GPS/cellular wireless communications station in the McGrimmon Holdings Fitness Centre.
- That Renfrew Town Council approve a Community Improvement Plan grant and direct staff to prepare a Financial Incentive Program Agreement with Nick Potvin for 142 Raglan Street South, for a transferable Tax Increment Equivalent Grant on a decreasing scale starting at 90% in Year 1 and declining by 10% annually to 0% in Year 10, for an estimated total value of \$19,997.41.
- That Renfrew Town Council adopt the revised Downtown Seasonal Encroachment Guidelines and pass the implementing by-law.
- That Renfrew Town Council endorse OCWA's Operational Plan, authorizing the Reeve (Acting Mayor) and CAO to sign the Owner Endorsement.
- That Renfrew Town Council authorize the Mayor and Clerk to sign the Product Care Association of Canada Municipal Hazardous and Special Products Materials Services Agreement.
- That Renfrew Town Council approve the suggested amendments to the Alternative Working Arrangement Policy, and further, that the appropriate bylaw be brought forward.
- That Renfrew Town Council direct staff on Option 2 regarding the Old Wastewater Treatment Plant — to postpone any demolition work and conduct regular site inspections to ensure fencing, signage, and the building remain secure.
- That Renfrew Town Council establish a Property Standards Working Group and approve the proposed Terms of Reference as presented, with direction to staff to bring forward the corresponding by-law for adoption.
- That Renfrew Town Council approve the appointment of a new business sector representative and adopt an amending by-law to remove the two non-participating members and formally appoint the new member.
- That Renfrew Town Council adopt the final resolutions considered in Committee of the Whole on October 21, 2025, including authorization for staff
