Update on Town's Official Plan – Phase 1: Jp2g Consultants presented an update on the Town's Official Plan. Council accepted the findings and directed the consultant to finalize the Planning Issues and Policy Options Report. Further, staff and consultants were directed to proceed with Growth Management and preparation of the Draft Official Plan. **Automated Speed Enforcement:** Council directed staff to respond to the Warden's letter regarding Automated Speed Enforcement and raise concerns regarding potential jurisdictional issues, costs for police enforcement, revenue sharing, and implementation of Administrative Penalties.

Local Efficiency Group (LEG): Council received the backgrounder on the Local Efficiency Group (LEG) and direct staff to prioritize discussions with neighbouring municipalities regarding the renewal of recreation agreements and the development of a potential fire training center.

Community Sport and Recreation Infrastructure Fund (CSRIF): Council endorsed an application to the CSRIF Grant and directed staff to initiate a Letter of Support for the Township of Admaston Bromley in support of their application.

Outdoor Lighting Ma-te-Way Park: Council approved the contracting of Jp2g to complete a site investigation and prepare a report with cost estimates to replace the outdoor lighting at Ma-te-Way Park.

- 91-2024: Amend the Corporate Credit Card Policy
- 92-2024: Amend the Kerry Canada Inc. Lease Agreement
