Reminder: As part of the process to register your marriage, it is recommended that you complete an application form for a Marriage Certificate following the date of Marriage Ceremony. Processing will typically take between six (6) and eight (8) weeks. Forms, fees, etc. will be included with your Marriage Licence or can be obtained on-line at http://www.ontario.ca/en/life_events/married/004444.



How to Get Married in Ontario

Congratulations on your forthcoming marriage! To provide certainty for our couples, the Town of Renfrew has this Marriage Information Package for all ceremonies conducted by our Marriage Officiants.

In the Province of Ontario, couples require a Marriage Licence issued by one of Ontario's municipalities in order to get married. The *Marriage Act, R.S.O. 1990, c. M.3* is the legislation that governs the procedures for getting married in Ontario. It also provides authority to Municipal Clerks and their designates to issue marriage licences and conduct marriage ceremonies.

Understanding your Marriage Licence

Once an application has been received, the Issuer will complete Parts One and Two of the Marriage Licence. When ready for pickup, the applicant (and/or joint applicant) can come in to pick up the licence at which time the person(s) present would sign Box 18 (Affirmation). If only one applicant came to pick up the licence, only this person should sign the Affirmation section of the Marriage Licence.

During the ceremony, your Marriage Officiant will complete Part Three (Statement of Marriage). This is also the section where you and your witnesses will sign during the ceremony.

After the ceremony, the Marriage Officiant will retain the Marriage Licence and tear off the "Record of Solemnization of Marriage" stub at the bottom of the licence. This piece is your record of marriage.

The Marriage Certificate Application Form can be completed online or by filling out the paper form attached at the end of this package. These processes are detailed more in depth later in this package (pages 6-7).



Civil Marriage Guidelines

Location:

Ceremonies take place at the Town of Renfrew municipal office located at 127 Raglan Street South, Renfrew, Ontario, Canada, K7V 1P9.

Bookings:

Marriage ceremonies are generally scheduled on Thursdays and Fridays during regular business hours and are based on availability.

Fees:

Marriage Licence

- \$125.00 for residents of the Town of Renfrew.
- \$150.00 for residents of another municipality.

Marriage Ceremonies

• \$250 + tax for Ceremonies conducted at Town Hall during regular office hours.

*Offsite ceremonies are not available at this time

Witnesses:

Two witnesses are required to be present during the ceremony. Although there is no minimum age for a witness, it is suggested that they should be at least 14 years of age and should be able to understand and appreciate what is taking place and be able to give evidence of such at a later date, if required. If you do not have witnesses, the Town may be able to provide them upon advance request.



Identification:

TWO of the following pieces of identification confirming both name, birth date, and signature (if applicable) are required for both applicants:

- An original birth certificate
- A current passport
- A Canadian citizenship Card
- A current Driver's Licence
- An Ontario Photo Card
- * ID must be valid and not expired
- * Ontario Heath Cards are not accepted

Interpreters:

If you do not understand or read English, you must provide your own interpreter and they must provide identification. The interpreter should not be one of the witnesses.

The Officiant has the right to postpone or refuse service should language and/or comprehension of the ceremony be a concern.

Expiry Date:

A marriage licence is valid for use anywhere in Ontario for a period of 90 days from the date of issue.

Ceremony Options:

The Town of Renfrew allows couples to choose from four (4) ceremony script options. Their selection should be submitted along with the Civil Marriage Ceremony Questionnaire.

- Civil Ceremony No. 1
- Civil Ceremony No. 2
- Civil Ceremony No. 3
- Civil Ceremony No. 4

Subject to approval by the Marriage Officiant, the couple may also personalize parts of the script, including vows.

If requested, music deemed by the Marriage Officiant to be appropriate to the occasion will be allowed. The Applicants must supply a music player for their recorded music.



Frequently Asked Questions

Where is the marriage ceremony performed?

The ceremony is performed in Council Chambers at Town Hall (127 Raglan St S, Renfrew, Ontario, Canada, K7V 1P8).

When can the ceremony be performed?

The ceremony can be held at Town Hall, Thursdays from 9:00 a.m. – 3:00 p.m. and Fridays from 9:00 a.m. – 12:00 p.m, subject to the Marriage Officiant's availability.

Who will be performing the ceremony?

The ceremony will be performed by a Town appointed Marriage Officiant.

How long will the ceremony take?

The ceremony takes less than 30 minutes, depending on the script option chosen.

What will be said at the ceremony?

The couple will be able to choose a custom script from the options provided in this package. Subject to approval by the Marriage Officiant, the couple may personalize parts of the scripts, including vows.

How many guests are permitted?

Council chambers can accommodate up to 25 guests.

How many witnesses are required?

Two witnesses are required to witness the ceremony. It is strongly suggested that witnesses be at least 18 years of age as they should be able to understand and appreciate what is taking place and be able to give evidence of such at a later date, if required. If the couple wishes to request that the Town provide witnesses for ceremonies in Council Chambers, please notify your Marriage Officiant as early as possible.

Are decorations provided for the ceremony?

The couple is welcome to supply flowers and a pre-approved music selection. Nothing like, or similar to candles, confetti, rice, incense or bubbles is permitted in Town Hall.



What fees are involved?

Marriage Licence

- \$125.00 for residents of the Town of Renfrew
- \$150.00 for residents of another municipality

Marriage Ceremonies

• \$250.00 + tax

Is photography permitted?

The Town of Renfrew does not provide the services of a photographer, but encourages the couple to enlist the help of a trusted guest or hire a professional photographer to document their special day.

What is a Marriage Certificate?

A marriage certificate is a record of a marriage. It lists the date and place of the marriage, and names of the people who were married. A record of solemnization of marriage is not the same as a marriage certificate.

How do I get my Marriage Certificate?

Before you can get a marriage certificate, your marriage needs to be registered. Your Marriage Officiant will do this by sending a complete and signed marriage licence to ServiceOntario (through the Division Registrar's office). You can then order a marriage certificate online or by paper application after your ceremony. Paper applications are available in the Clerk's Office upon request.

How do I change my name after the ceremony?

There are two ways that you can change your name; Assume (take your spouse's last name in practice without changing your birth certificate) or Elect (legally change your name).

Assume

Assuming a spouse's name after marriage does not change the name on your birth certificate. However, you can assume your spouse's name on government documents such as:



- Health card
- Driver's licence
- Ontario Photo Card
- Enhanced driver's licence

There is no cost to assume a name on the above documents.

To assume your spouse's name, visit a ServiceOntario centre with the following documents:

- marriage certificate (not the marriage licence, but the document that proves you were legally married)
- current photo health card (if you do not have a photo health card, you
 must bring 3 original documents to prove you are a Canadian citizen and
 Ontario resident)
- driver's licence, enhanced driver's licence or Ontario Photo Card

Elect (Legal Name Change)

You can legally change your name after marriage, or if you are in a common law/conjugal relationship. If you were born in Ontario, legally changing your name will change your name on your Ontario birth certificate.

When you legally change your name, you get a certificate of name change and a new birth certificate (if you were born in Ontario). Use these documents to update other forms of government-issued identification (e.g., driver's licence).

You can legally change your last name if you:

- 1. Were born in Ontario
- 2. Are married or in a common law/conjugal relationship and would like to change your name on your birth certificate

How to Get Married in Ontario 101

Marriage Licence applications can be obtained upon appointment and or by email request through the Clerk's Office located at the Town Hall (127 Raglan St S, Renfrew, Ontario, Canada, K7V 1P8) or online.

Please review all Marriage Licence Requirements below completing the application.

Office Hours for Issuance of Marriage Licences

By appointment from Monday to Friday 8:00 AM to 4:00 PM. Municipal offices are closed on all government statutory holidays.

Marriage Licence Fees

\$250.00 + tax

• Payable by cash, cheque or debit

Marriage Licence Requirements

Age Requirements

Any person who is at least 18 years of age may marry.

Applicants who are 16 or 17 years of age are required to submit a completed Consent of Parent or Guardian to Marriage Form signed by both parents (or legal guardian) when making an application for a marriage license. The Consent of Parent or Guardian to Marriage Form is available through the Town upon request to the Clerk's Department.



Identification

Original identification for both applicants is required. Identification must be shown for each party confirming name, birth date and signature.

First piece of identification must be one of the following:

- Birth Certificate
- Current Passport with photo
- Record of Immigrant Landing
- Canadian Citizenship Card
- Drivers License
- Current Passport with photo (providing it is not used as the first piece of identification)

These documents are required for all applicants. Documents presented in a language other than English, must be supported by a translation by an authorized translator.

Obtaining a License When One Applicant is Absent

One applicant to the marriage may submit the completed application form to the Town's Customer Service Centre in order to obtain a Marriage License, provided that the required original identification/documentation for the absent party is presented. The application must be original and signed by both applicants.

Prior Marriage

Canadian Divorce

If there has been a previous marriage and the divorce was granted in Canada, you are required to bring the original Certificate of Divorce or the Decree Absolute, or a court certified true copy of same, along with your marriage license application. Please note that a photocopy is not acceptable. Also a Divorce Judgment, Divorce Order or Decree Nisi issued by the Court is not acceptable. All documents will be returned.

Divorce Outside of Canada

An applicant whose former marriage was dissolved or annulled in a jurisdiction other than Canada must obtain authorization from the Office of the Registrar General before a marriage license may be issued.

To obtain this authorization, the applicants or a lawyer representing the applicants, must submit:

A completed Marriage License Application



- A Statement of Sole Responsibility for each divorce signed by both parties of this marriage. Blank affidavits are available at the Town.
- The original Certificate of Divorce or the Decree Absolute, or a court certified copy of same. If the decree is in a language other than English or French, include a translated copy together with an affidavit sworn by the translator. (A court-certified copy means certified by the proper court officer in the jurisdiction the divorce or annulment was granted.)
- A legal opinion of an Ontario Lawyer, addressed to both applicants, giving reasons why the divorce or annulment should be recognized in the Province of Ontario.

Widow or Widower

If either party to the marriage license application is a widow or widower, they are not required to produce a death certificate to obtain a marriage license.

Residency and Citizenship

There are no residency or citizenship requirements in Ontario.

Declaration Made by Applicants

When applying for a marriage license, you are required to certify information under oath.

If you do not understand or are not able to read English, please bring an interpreter to assist you.

Expiry Date of Marriage License

A marriage license is valid for use anywhere in Ontario for 90 days from the date of issue.

Marriage Ceremony

It is your responsibility to arrange the marriage ceremony. A marriage ceremony may be performed in Ontario by a minister, clergyman or Town Clerk registered under the Marriage Act.



Publication of Banns

A marriage may be solemnized under the authority of the publication of banns if both parties to the proposed marriage worship regularly at their own church in Canada.

No one may marry under the authority of the publication of banns if there was a previous marriage (dissolved or annulled). Further information concerning marriage under the authority of the publication of banns may be obtained from a minister or a member of the clergy.

How to Obtain Old Marriage Records

The Office of the Registrar General holds records of marriages that happened in Ontario during the past 80 years. For information on older records you should refer to the Archives of Ontario Website or the Vital Statistics hot line at 416-327-1593.
