

## **TOWN OF RENFREW** PRE-AUTHORIZED CHEQUING PLAN **AGREEMENT**

The Town of Renfrew offers a "Pre-authorized Chequing Plan" for the payment of realty taxes and/or water/wastewater charges. Those wishing to enroll must adhere to the following:

- Pay all arrears in full prior to application.
- Complete the agreement and return to the Municipal Office.
- Attach a VOID personal cheque.

## TAX PLAN - MONTHLY

Commences in January with eleven (11) equalized payments based on the previous years taxes plus 2%, with an adjustment when the final taxes are levied. Payments will be withdrawn from your bank account on the 15th of each month with the exception of December, when there will be no withdrawal. Supplementary billings are not included in this plan and have to be paid separately.

## TAX PLAN - INSTALLMENT

Payments are based on the actual billing and will be withdrawn from your account on the due dates shown on your tax bill, usually four (4) times per year.

## WATER/WASTEWATER PLAN - INSTALLMENT ONLY

Payments are based on the actual billing and will be withdrawn from your account on the due date shown on your bill.
