

## Town of Renfrew Council Meeting Summary Tuesday, June 13<sup>th</sup>, 2023

**Sunshine Coach Presentation:** Council received an update on the Sunshine Coach. It was noted that the fleet has 18 accessible vehicles and prior to the COVID-19 pandemic conducted roughly 36,000 trips a year for residents in Renfrew and the surrounding area.

**Gillan Road Rehabilitation Project:** Renfrew Town Council awarded the Gillan Road Rehabilitation Project to Greenwood Paving LTD. for \$632,186.05 including HST. Work will include asphalt restoration and the establishment of an asphalt multiuse pathway from Hall Avenue to O'Brien Road. The project is expected to start September 5<sup>th</sup>, 2023 with substantial completion on October 16<sup>th</sup>, 2023.

**Maloney Culvert Replacement:** Renfrew Town Council awarded the replacement of the Maloney Road Culvert to RGT Clouthier Construction LTD. for \$567,370 including HST. Late in 2021, it was determined that the culvert allowing water to pass under Maloney Road had failed. The culvert replacement project will also include a new guide rail, slope stabilization and asphalt within the project limits. The project is expected to start September 5<sup>th</sup>, 2023, with substantial completion on October 27<sup>th</sup>, 2023.

**Hunter Gate Subdivision Phase 5-6 Early Servicing Agreement:** Renfrew Town Council approved an Early Servicing Agreement for the Hunter Gate Subdivision at the east end of Hall Avenue. The project has advanced to the stage where servicing can begin. Further approval will be required by Council prior to division of lots and construction of new homes. Development of this subdivision will increase the future residential tax base for the Town of Renfrew. A total of 94 new homes will be built in Phases 5 and 6.

Collection of Non-Eligible Source During Blue Box Transition: The Town of Renfrew blue box recycling program will transition from a shared steward and municipal responsibility to full producer responsibility for eligible sources on July 28<sup>th</sup>, 2023. Renfrew Town Council approved the offer from Topps Environmental Service to collect non-eligible recycling during the transition period up to 2026. There will be no impact to the recycling schedule or types of materials that can be placed in your blue box.
