RULES & REGULATIONS:

By signing below, I acknowledge and agree to the following event rules and regulations:

1. **Fee:** There is a \$25.00 Vendor Application Fee that must be paid previous to set up.
2. **Accepted Mediums:** Only original photographs, paintings, pencil/charcoal drawings, sculptures, fused glass, or other recognized fine art media will be permitted.
3. **Prohibited Items:** Art generated by AI (Artificial Intelligence), soaps, candles, jewelry (unless created as fine art), knitted/crocheted goods, mass-produced crafts, and imported art are not permitted.
4. **Originality:** All work displayed and sold must be the artist's own original creation — no reproductions from stock images or other artists' designs.
5. **Quality Standard:** All pieces must demonstrate a professional level of skill, composition, and finish.
6. **Booth Space:** Each artist will be provided with one 10' x 10' space.
7. **Equipment:** Artists must supply their own pop-up tent, tables, chairs, and all display materials. Tents must be properly weighted for safety.
8. **Power:** Power is not provided. Vendors requiring electricity must supply their own via a quiet generator or inverter.
9. **Set-Up & Take-Down:** All vendors must be fully set up by 9:30 AM. Vendors may not dismantle or leave until the event ends at 4:00 PM.
10. **Parking:** Vehicles are not permitted to remain at vendor booths. Artists must unload their work and park in the designated parking area.
11. **Weather:** This is a rain-or-shine event. No refunds will be issued due to inclement weather. If severe weather event will be moved to Sunday, September 14.
12. **Liability:** Artists are responsible for their own work, equipment, and personal safety. The event organizers and venue are not responsible for loss, theft, or damage.
